## SATTB World 2023 Championships Logo Design Contest Submission Guidelines

- Deadline for entries is **9<sup>th</sup> July 2021** entries are free and can be mailed to South African Table Tennis Board, PO Box 14510, Clubview, Centurion, 0014 or submitted by email to: [sattb@tabletennis.co.za](mailto:sattb@tabletennis.co.za)
- Three entries may be submitted by one entrant. Each entry must be submitted with a completed entry form.
- The technique used can be free: drawing, painting, computer design, and photography, all adaptable to printing.
- The logo must be presented in A4 and the dimension of the logo will be the maximum 15×15 cm, which does not imply that it should be a square shape.
- Flexibility of the design – logo must be easily resized, look good in **black and white, grayscale and color** and be suitable for high quality printing. If emailed logo needs be a in a **PDF format with a 300 dpi** or higher resolution.
- Entrants should take care to ensure their entries are not in any way similar to existing logos or other copyrighted images and are **original art work**.
- The logo must contain the words **“ITTF 2023 World Table Tennis Championships”**.
- The logo should ideally represent **Durban/South Africa and Table Tennis**.
- The winning logo will be the property of the SATTB to publish, display or reproduce, to market or use in advertising through any type of media including but not limited to: website, social media sites, newspapers, brochures, letterheads, banners, signs, posters, t-shirts and bags.
- The winning logo will be announced on the **31<sup>st</sup> July 2021**.

### Judging and Selection of Winner

- The winning design will be selected by the Logo Adjudication Panel of the SATTB. Their decision will be final. No further correspondence shall be entered into.
- Logo Adjudication Panel of the SATTB reserves the right to not select a winner if, in its' sole discretion, no suitable entries are received.
- The SATTB reserves the right to make public and otherwise use the winner's name for publicity purposes. Further personal data may be requested but is not required.

**Acceptance**
